

RESOLUTION NO. 18-256

A RESOLUTION ACCEPTING THE BID OF SAHASRA, LLC, D/B/A BROOKE CLEANERS, TO PROVIDE AS-NEEDED DRY CLEANING SERVICES FOR VARIOUS CITY DEPARTMENT UNIFORMS AT AN ESTIMATED ANNUAL COST OF \$29,930 FOR A TERM OF ONE YEAR, WITH OPTIONS TO RENEW FOR FOUR ONE-YEAR TERMS; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT WITH SAHASRA, LLC, D/B/A BROOKE CLEANERS, CORRESPONDING TO THE BID DOCUMENTS; AUTHORIZING THE CITY MANAGER TO EXERCISE THE CITY'S OPTIONS TO RENEW, SUBJECT TO BUDGETING AND APPROPRIATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids were duly called for and advertised for as-needed dry cleaning services for various City department uniforms; and

WHEREAS, bid opening was on May 29, 2018, the Bid Tabulation being attached hereto and made a part hereof; and

WHEREAS, the Chief Financial Officer recommends that the City accept the only bid submitted, by Sahasra, LLC, d/b/a Brooke Cleaners, at an estimated amount of \$29,930, and the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsive bidder is the following:



SECTION 2. The bid approved in Section 1 above is hereby accepted subject to the terms and conditions of the bid documents.


