- 1. During a recent Pre-submittal meeting with the land development office a few items were discussed: As part of the Form Based Code, a 6' buffer will need to be on the North side of the parking lot. This area may be used for a bio-swale as part of the storm water requirements. Also a 30'setback from the road. The LDO said it looks to already be 25' so when you add the first landscape islands, you should meet that requirement.
- 2. Access to the Lot. During the site visit, Talley's Forman mentioned they would be past the Driveway this week, and access should not be a problem from the North end of King Street.
- 3. As part of this RFP the requirement set forth in Appendix A are required. Make sure to put form 00201-1 on the outside of the proposal.

- 5. Q: Should we design this parking lot for heavy or light duty vehicles? A: The expected Structural Number was included on page 13 in the RFP. The Pavement Design is expected to meet or exceed a 2.28 structural Number.
- 6. Q: The water problem at the existing building, in the City's view, is this an issue from surface water and down spouts or is there a water infiltration under the surface entering into the basement?

  A: The surface water is all that is expected to be handled under this contract.
