ELECTRICAL DRAWINGS/SPECIFICATIONS

- 1. **CLARIFICATION:** In response to the recent RFI concerning breakers for the HVAC units in panel "A", there are no 3-pole breakers presently in panel "A" and the contractor is to furnish all breakers needed for the project. There are a few 20A. 1-pole breakers in the panel which can be used. I would estimate there are (25) single pole breakers and approximately (14) spaces available. From my records, I don't see that the panel is labeled for its AIC rating. If the utility would ever upgrade the remote pole-mounted transformer to a pad-mounted transformer, I would expect a fault current availability of 400/.035 amps or 11,450 amps. New breakers should be rated 22k AIC.
- 2. <u>CLARIFICATION</u>: On Sheet E1-01, Panel B is new. It is not existing. Panel A is the only Existing Panel.
