Question 1: Will you allow site inspections outside of July 16th? I can send someone from my office to the pre-bid meeting, but would like to do a site visit next week if possible as I'm on vacation the week of July 15-19th.

Response: While this was not the County's original intention, we will allow this to get the best pricing and most bidders possible. Please contact Donny Cummings at 843-833-9349 to schedule any follow up site visits needed. You will still need to have a person from your firm sign-in & present at the mandatory pre-bid meeting in order to be considered a qualified bidder who is able to submit a bid.

Question 2: Is there access to the roof from inside or do we need to bring a ladder with us to the pre-bid meeting?

Response: One side has access but a ladder is needed to access the other side. Georgetown County will provide a ladder for bidders to use the day of the pre-bid meeting to access the roof as needed.
