- 10. I noticed that there are side streets that have baselines, but on those baselines, there are no bearings or distances. On these side street baselines, they give call outs for us to build, but with no way to construct the baselines, these call outs do not help us any. Is the County able to provide more information?

PROJECT DESCRIPTION:

The project will consist of the reconstruction and widening of the intersection of SR 60 and 43rd Avenue and the widening of the existing bridge over the Main Relief Canal. Drainage improvements will consist of structures, piping and retention areas. Concrete sidewalks, 5' wide and 6' wide, will be constructed, utility relocations will be performed, landscaping, traffic and pedestrian signals, lighting and pavement markings will be installed. Earthwork, erosion control and maintenance of traffic will also be performed. This is an FDOT, On-System, County Incentive Grant Program (CIGP) funded project FM No. 431759-2-54-01.

This is a FDOT On-System project therefore, full FDOT requirements must be met for construction, which includes the materials testing. The MACS System will be used for recording sampling for all material testing results. The Contractor will be required to meet full QC requirements set forth in the contract specifications. Additionally, pre-operation meetings will be required consistent with FDOT specifications.

Questions & Answers

- Diego Velasquez FDOT This is a CIGP 50/50 grant funded project. FDOT will be providing oversite. Requires QC and VT testing. FDOT specs MUST be met. Certifications for the drill shafts and all bridge work. Work will be verified by FDOT Structures Inspectors.
- James Ennis The following meetings will be required; Pre-Drill shaft, Pre-Deck
 placement, and Pre-paving. QC plans will be required per FDOT specifications, etc. All
 material must be from the FDOT approved products list.
- Shop drawings shall be provided in advance of work being performed to provide ample time for review, as set forth in the specifications.
- Maintenance of Traffic plan should be one of the first submittals by the Contractor.
 All work being performed with the IRFWCD Canal shall be coordinated with David Gunter, Superintendent of the Water Control District.
- David Gunter, Indian River Farms Water Control District Noted in order to meet turbidity requirements, pilings and concrete sheeting must be driven and not jetted. Excavation of the canal will be permitted with prior proper approval. The canal flow can be stopped for short periods of time during the dry season if necessary.

Question: What is the curing time of asphalt prior to placing thermoplastic.

Answer: 14 days.

Question: Are there any sound ordinances preventing night work? Answer: Night work will be considered on a case by case basis.

Question: Should the bidder base his bids on a 7:00 AM – 5:00 PM work day 5 days week

excluding County holidays?

Answer: Yes it should be based on a 5 day/week 7:00 AM-5:00 PM work day. Additional work

hours and weekend work will be considered on a case by case basis.

Contractor will have to pay for inspector's time outside of the normal County work day.

No blanket approval will be given.

Question: Can plans be provided as vectorized pdfs or cad files?

Answer: Yes, the Consultant will provide vectorized pdfs for bidding purposes as part of an addendum.

Question: Can the County provide pay items on an excel spreadsheet?

Answer: Yes, the County will provide excel spread sheet as part of an addendum.

Question: Can we get the sign in sheet?

Answer: Yes, the sign in sheet will be uploaded to Demandstar following this meeting.

Question: What is the policy of the County in the case of a Hurricane event?

Answer: The successful bidder will be required to submit a Hurricane Preparedness Plan and

requires the Contractor to follow it.

This will be discussed in further detail at the preconstruction meeting.

David Gunter – Stated 72-hour prior to a storm event the canal gates will be wide open, all equipment and materials are to be removed from the Canal prior to this time frame.

Question: Is there a DBE requirement?

Answer: No.

Question: Why is there no bituminous adjustment required if we are following FDOT specs? Answer: It is County policy to not utilize this portion of the FDOT specifications. FDOT has approved the County specs and has allow them not to participate.

Question: Is a modified spec is being used?

Answer: Yes.

Question: The Traffic Control Plans state works hours between 8:00 AM and 6:00 PM? Answer: The 7:00 AM to 5:00 PM work day stated in the Contract Documents supersedes general notes on the plans.

Question: Is it required to coordinate a site visit as stated in the Instruction to Bidders?

Answer: No, however, if bidders are going to be in traffic or closing a lane a MOT plan will

have to be submitted prior to any testing or field investigation. If going into the canal area bidders shall contact IRFWCD to let them know.

Question: On Sheet 20 of 58 what do the hatch patterns signify throughout the plans? Answer: The legend is located on Sheet 38 of 99 of the Roadway Plan sheets.

Question: Is there a Utility relocate schedule that is attached to this project?

Answer: The utility matrix is located on sheets 27A through 27D of 99 in the plan set, all current Utility Work Schedules will be provided in Addendum.

Question Part one: Lighting, the load centers are outside DOT standards by being pole mounted?

Answer: They are on 43rd Ave. and do not have to meet FDOT standards.

Question Part Two: You are going to put them on a ten-foot pole and insist on the meter being mounted at 5 feet?

Answer: This is to be bid as shown.

Question: The Engineer of Record is specifying Miami-Dade APL distribution center which is molded, mg squared and very expensive. This brand is not the only one on the FDOT APL. Answer: These items are to bid as specified. Approved equal will be considered.
