Black Creek Water Resource Development Aquifer Recharge Area Project

Please be advised of the following changes to the subject Two-Step Invitation for Bid:

1. The time and date for the submittal of qualifications submittals remains: 2:00 p.m., June 9, 2023.

- 2. The time and date for the receipt of competitive sealed bids remains: 2:00 p.m., July 6, 2023.
- 3. **Question:** For Part 8.a, can you further clarify the qualification process? The specification seems to indicate the prime contractor must have performed two similar projects with lined basins, earthwork and storage tanks. My question is if we are the prime and intend on subcontracting out the tank, would that be acceptable assuming our subcontractor meets the qualifications required for installation of storage tanks??

Answer: The intent of qualification was that the Respondent (or a combination of the contractor or project manager assigned to the work) have successfully completed projects which included the key elements.

The District acknowledges the Respondent (i.e., prime contractor) may have used subcontractors to complete electrical and other work. In such instance, the Respondent must have been managing the subcontractor(s) performing completing that work (i.e., electrical and other work).

4. **Question:** Then in Part 8.b, please explain this additional storage tank qualification. Aren't we already qualifying in part 8.a?

Answer:

The ground storage tank and liner requirements have been removed from minimum qualification 8.a.

The ground storage tank minimum qualification requirement is to be met under minimum qualification 8.b.1. If the Respondent's qualifying project under 8.a includes the installation of a 250,000-gallon ground storage tank, the Respondent may also use that qualifying project to meet the 8.b.1 minimum qualification requirement. Otherwise, a separate qualifying project must be used to meet minimum qualification 8.b.1.

Furthermore, if one of the Respondent's qualifying projects under 8.a includes the installation of at least 5,000 LF of 24" (or larger) diameter water main piping, the Respondent may also use that qualifying project to meet the 8.b.2 minimum qualification requirement. Otherwise, a separate qualifying project must be used to meet minimum qualification 8.b.2.

Furthermore, if one of the Respondent's qualifying projects under 8.a. includes the installation of at least eight acres of liner in earthen basins, the Respondent may use that qualifying project to also meet the

8.b.3 minimum qualification requirement. Otherwise, a separate qualifying project must be used to meet minimum qualification 8.b.3.

The District acknowledges the Respondent (i.e., prime contractor) may have used subcontractors to install the basin liner. In such instance, the Respondent must have been managing the subcontractor(s) installing the liner.

5. On Pages 7 & 8, <u>delete</u> Paragraph 8. MINIMUM QUALIFICATIONS in its entirety and <u>replace</u> it with the following:

"8. MINIMUM QUALIFICATIONS

Respondent must use the "Qualification" forms (General, Similar Projects, and Client References) provided in these documents to document the minimum qualifications listed below. If Respondent fails to include these forms and the Respondent-provided documentation requested below for Step 1 of the solicitation process, Respondents submittal may be considered non-responsive.

- a. <u>Similar Projects (Two Projects Similar Nature)</u>: Respondent (or a combination of the contractor or project manager assigned to the work) must have **successfully completed** as the prime Contractor at least <u>two</u> projects of a similar nature that included (earthen basins, earthwork, mechanical/piping work, and electrical work within the 10 years immediately preceding the date for receipt of Qualification submittals. The District recognizes that subcontractors may have performed portions of the qualifying projects.
 - 1. One of the qualifying Similar Projects must also have had a project value of at least \$5,000,000.
 - 2. The other qualifying Similar Project must also have had a project value of at least \$3,000,000.

Respondent is cautioned to ensure that the contact information (names, email addresses, and phone numbers) is correct, and that the proposed contact is amenable to speak with District representatives and/or respond to a written inquiry. The District will contact the references to verify the information as it relates to this solicitation. If the information provided by Respondent cannot be verified by the District, or the proposed contact person fails to respond to the District's inquiry, Respondent's Qualification submittal may be considered non-responsive.
