FAILURE TO DO SO MAY, AT THE OWNER'S DISCRETION, SUBJECT THE BIDDER TO DISQUALIFICATION

<u>QUESTION</u>: On drawing "LSP" it shows that there are to be strobe lights in the restrooms along with automatic smoke detectors. On drawing "E2.1" there are no strobes shown and also appears to be using 120VAC smoke detectors. Please confirm which type of smoke detection is required? 120 VAC smokes or a fire alarm system that includes both strobes and smoke detection.
 ANSWER: Delete two strobes on LSP 120 V AC smoke detection on single circuit

<u>ANSWER:</u> Delete two strobes on LSP. 120 V AC smoke detection on single circuit required.

2) <u>QUESTION:</u> The A-Set drawings do not specify low-voltage cabling or any security cabling requirements such as card readers and video cameras. Could you please confirm these Divisions need to be covered in your Scope, and if so, can we please get some additional information?

<u>ANSWER:</u> No card Readers or cameras included in contract. low voltage drops shown are conduit stubbed up above the ceiling with pull string.

- <u>QUESTION:</u> Fire Service and Sprinkler Not shown. Required per Code? <u>ANSWER:</u> No sprinkler in contract
- <u>QUESTION:</u> Fire Alarm Control Panel & Annunciator, LSP Location(s) not shown. Is annunciator required? Does not seem to be enough FA devices to meet code; please confirm.
  <u>ANSWER:</u> No Fire alarm included in contract
- <u>QUESTION</u>: 2nd Floor/Mezzanine Framing Not shown on Structural, Arch references on A1.2 & A3.2 appear adequate. Is a PE design required? <u>ANSWER</u>: PE Design not required
- 6) <u>QUESTION:</u> 2nd Floor/Mezzanine Flooring Shows only <sup>3</sup>/<sub>4</sub>" plywood with no finish/paint. Assume plywood must be fire rated?
  <u>ANSWER:</u> Yes, Mezzanine to receive <sup>3</sup>/<sub>4</sub>" fire treated plywood

- 7) <u>QUESTION:</u> Ship Ladder, 3/A3.1 No horizontal distance shown. <u>ANSWER:</u> Base of ship ladder is 4' from wall
- <u>QUESTION:</u> Recirculation Pump & Louver MOD power, E2.2 Circuit A53 appears shown for both items, including a switch. Should louver MOD be on its own nonswitched power? <u>ANSWER:</u> No. Power is fine as shown MOD required very little power to operate
- <u>QUESTION:</u> Confirm if truck bays will get any floor finish such as polished concrete, epoxy flooring, etc.
  <u>ANSWER:</u> Truck bays to receive 2 coats of MasterKur CC300SB
- <u>QUESTION:</u> Piping for the four floor drains in the vehicle bays is not shown on the plumbing drawings. Please provide information for under slab rough in. <u>ANSWER:</u> See Floor Drain Piping attached to this addendum
- 11) <u>QUESTION:</u> Is a building permit required? If so, is there a cost associated with the permit that will have to be paid to Effingham County? Are all the fees listed on the permit application to be paid by contractor?
  <u>ANSWER:</u> Building Permit Required Fees will be waived
- 12) <u>QUESTION:</u> Please confirm depth below finished floor for the footings. <u>ANSWER:</u> See structural drawings S1.2
- 13) <u>QUESTION:</u> Is it the responsibility of the site contractor or building contractor to provide the 4" of sand under the slab? <u>ANSWER:</u> Site contractor
- 14) <u>QUESTION:</u> What are the specs for the Alemite light? <u>ANSWER:</u> ALEMITE 7260 CORD REEL 20 AMP 115 V12 GA 45 F
- 15) <u>QUESTION:</u> What are the "O" on the floor plan? Gound spotlights?
  <u>ANSWER:</u> The O on the floor plan next to the front and rear passage doors are the wall sconces. Delete 3 Os on floor plans
- 16) <u>QUESTION:</u> Will a fire extinguisher be needed in the kitchen?
  <u>ANSWER:</u> Contractor shall provide 1- 15# type K fire extinguisher and wall mount bracket for kitchen. Owner to determine location
- 17) <u>QUESTION:</u> How will the 2nd floor tie into the 2hr fire wall?<u>ANSWER:</u> Second Floor abuts the 2 hour wall. Floor does not tie into wall
- 18) <u>QUESTION:</u> What are the locations of the down spouts/ gutters? Over rollup doors? <u>ANSWER:</u> No gutter or downspouts included in contract
- 19) <u>QUESTION:</u> Who is responsible for the metal garage heater bracket? <u>ANSWER:</u> General contractor / subcontractor
- 20) <u>QUESTION:</u> How thick is the brick ledge on C/S 1.2? <u>ANSWER:</u> 8"

21) **<u>OUESTION</u>**: How to connect Carbon Monoxide sensor to fans?



- 24) <u>QUESTION:</u> Please confirm extent of GC's responsibility for TV/data cabling scope <u>ANSWER:</u> Contractor to provide conduit and pull strings for low voltage as shown on plans.

- Apply a continuous, uniform film by short-nap roller or lamb's wool applicator. Spraying is not recommended.
- 3. For curing, one coat may be sufficient. However, two coats may be required in hot and windy conditions. Apply evenly and uniformly as soon as possible after final finishing.
- 4. To seal and dustproof, two coats are required. Apply the second coat when all trades have completed their work and site is ready for occupancy.
- 5. Do not overapply or soak concrete surfaces with the curing compound. Do not allow the curing compound to pool on the surface. Overapplication can result in alligatoring and mud cracking, whereby a film forms on the substrate before the material dries properly.
