1. Should we purchase the plans or they are free?

2. Is necessary to have GDOT Prime Contractor?

Answer: The bidder must also submit a bid on 17-PW10 Milton Streetscape Project P.I. No. 0011675 to be eligible to submit on 17-PW11. All prime requirements are the same as 17-PW10 Milton Streetscape Project P.I. No. 0011675.

3. On the schedule project cost spreadsheet item #22 / [item#23 and item #24] Landscape Allocation @ \$15,000.00....will you please provide a detail explanation on how do this amount of money all ready included in the total bidders cost spreadsheet? Our concern, is this amount all ready included could make a bidder's total bid amount more for the entire project, and this amount will certainly effect item #23 and item #24 bid amount.

*Answer: Item #22 on both the base bid and alternate #1 is listed as Miscellaneous Construction for **Special Provision Section 999** (<https://files.secureserver.net/0sojIB0o1qLzAT>). Items 23 and 24 were removed as line items. Any testing shall meet GDOT Specs for type, method, and frequency. This work shall be considered incidental to the rest of the work and no separate payment will be made. Mobilization, bonds and insurance costs should be included in other lump sum items as determined by contractor and no separate payment will be made.*

4. Item #22 allocation is very confusing. Please revised in your explanation.

Answer: See answer to question #3

5. Please, take a look @ item #24 until item #22 is straight out item #24 is not going to balance the 5% and going to cause the base bid to be a [+ or -] to high or low for the project please advise on how you wish to handle this concern.

6. On page #5, you stated that answers will be posted on 09/15/17 and the bids are due 09/20/17, in the 5 days space will the bidders have a chance to re-ask question and express any other concerns if your answers of not clear?

Answer: We intend to post any final addendum no later than 09/15/17. This Addendum #2 will be posted by 09/13/17. Any requests for clarifications needed based on the addendum should be submitted by 9/14/17.

7. Are you budgeting or estimating item #22 Landscape not to exceed the allocation of \$15,000.00?

8. What if the bidders (contractor's) can do this part of the project for less?

9. Are you going to do a deduction change-order or an added change-order if this item #22 is less or more than the allocation of \$15,000.00?

13. Do this project have any type of federal funds in this project, under

GDOT'S programs?

Answer: The bidder must also submit a bid on 17-PW10 Milton Streetscape Project P.I. No. 0011675 to be eligible to submit on 17-PW11. Project 17-PW10 Milton Streetscape Project P.I. No. 0011675 does have federal Transportation Enhancement funds.

14. On item #23 [1 lump sum amount] how will this item be handled if this item cost the contractor more than the bid amount? Without a prior soil testing reports, before bidding this project the bidders don't have a clue what is going on. Please, provide the soil testing reports and soil boring reports.

15. On page #32, you stated a deduction "if" the changes. Will the contractor be allowed to maintain his or her G/A and profit if this happen on this project?

16. Our recommendation to avoid item #22, from inferring with item #23 and #24! Perhaps, do an added alternate without item #22 of \$15,000.00 for the base bid amount. But the bidder's still would included this amount in the PP-bonds cost.
