Offerors Questions:

1. Question: In the Special Bidder Qualifications section of the Summary of Services Required (page 3 of the Invitation to Bid) has item C which states: "The On-site Project Manager/Superintendent shall provide a list of completed facilities within the past 5 years. This list shall include a minimum of 5 running tracks which are certified to meet NFSHSA rules and regulations in the past 5 years utilizing the products specified in the attached specifications." Please confirm this requirement is meant only for the Track & Field Vendors, not General Contractors.

Answer: This reference in the Special Bidder Qualifications is from Specification Section 321823.39 Synthetic Running Track Surfacing Part 1.3.A.2.b and refers to the Track & Field Synthetic Surfacing Contractor On-Site Project Manager/Superintendent. There are similar requirements for Track & Field Paving Contractor On-Site Project Manager/Superintendent listed in Section 321216.36 Athletic Track Asphalt Paving Part 1.3.C.

Specifications have been revised, changes to Contract Documents:

- Specification Section 116833 Outdoor Sports Equipment
 - o Part 1.1 Work Included, Subpart A.1 Football Equipment:

Add the following language: "b. Play clock support post padding"

o Part 1.2 Submittals, Subpart B.2 Product Data:

Add the following language: "2. Play clock support post padding"

o Part 2.1 FOOTBALL EQUIPMENT:

Add the following language: <u>"B. Play Clock Support Post Padding</u>

- 1. I-Beam Post Padding:
 - a. Square design x 4-ft height (verify in field)
 - b. Premium fully encased construction
 - c. <u>2" high density foam and outdoor vinyl</u>
 - d. Standard vinyl colors
 - 2. <u>Products and Suppliers:</u>
 - a. <u>Sportsfield Specialties, Inc. (www.sportsfieldspecialties.com)</u>
 - i. Model #SBP6 (6" max. inside dimension verify in field)
 - b. Or approved equal."

Refer to attached revised plan sheets for Loris High school, sheets C-002 and C-100 to show the removal of the field fencing, changes to the filed gates, and play clock post padding.
