Amendment #1 addresses questions that were received.

1. As far as power to the sign, if there is no power, the owners will have to get the power company to supply power to a new service meter near the sign base. Sign companies are not licensed electricians and cannot do this legally. We will have to add in a local licensed electrician to build a meter base for the new sign and then the owners will have to request the power to be set. Is there any other location that power can be pulled from? Light pole, existing sign power, etc.

2. It says masonry is required for this project... At the meeting you said you would consider an alternative if it were significantly cheaper. Most of our school districts that we've worked with go with our aluminum wrapped bases. If they have pre existing brickwork or other types of masonry, we can retro-fit our displays into them. It will definitely be more expensive to add brick work along with matching up to the brick design on the school building.

CLARIFICATION: WE DID NOT SAY WE WOULD CONSIDER IT IF IT WAS CHEAPER. WE SAID WE COULD CONSIDER IT AS A POSSIBLE SUBSTITUTE, BUT THE SPECIFICATIONS STATE BRICKWORK. THE DISTRICT HAS USED BRICKWORK IN MOST ALL CASES. IT IS UP TO THE VENDOR TO CONVINC THE DISTRICT THAT THE FUNCTION AND APPEARANCE IS ACCEPTABLE.

3. Do you know what type of communication that will be required? We offer direct Wi-Fi, HD wireless line of site radios, and also 4G cellular. I would suggest the 4G cellular, this will allow you to be on our cloud base software and you will be able to remote access your sign from anywhere on any device.

4. What kind of warranty package are you looking for? Our standard is 5 years on replacement parts, (new parts) not refurbished. 1 year on-site labor. Lifetime on our structures.

5. Are you requiring that the sign company must have in house service technicians?

6. Are you requiring that the sign company have readily available parts in stock at their facility? We keep all parts for our displays in stock at our facility in Lugoff along with over 200 displays ready to install.
