SUBMIT OFFER BY (OPENING DATE) AND TIME REMAINS THE SAME.

Solicitation Page 24, section VIII. BIDDING SCHEDULE/PRICE-PROPOSAL has been revised and is attached.

- 1. Can you please confirm if decommissioning of old well includes the removal of existing concrete pad?

 Answer: Yes, contractor will be required to remove and dispose of existing concrete pad.
- 2. For new well and pump, is the power requirement 230v 3PH for VFD?

Answer: The power requirement will be 480v; 3PH for the VFD.

3. Will there be a water supply for drilling new well? What is the source? Will drilling mud and fluid be disposed of onsite?

Answer: No, there is no water supply available. Whatever drilling source is required must be provided by the contractor. No, drilling mud and fluids will not be disposed of onsite.

4. Does contractor only provide VFD or provide and install?

Answer: The Contractor will provide and install the VFD.

5. Are replacement pumps and motor for additional two site CFHS and GSFHS estimating to be the same design 65GPM at 70PSI?

Answer: Yes.

6. Is the power for the replacement motors and pumps also 230V, 3PH or SINGLE PHASE? 460v? Answer: The power for the replacement motors and pumps will need to be 480v and 3PH.

- 7. Will the pumps and motors at the additional two sites require VFD to be provided? Answer: No.
- 8. Does the project have a completion date from awarded date?

 Answer: Yes, the substantial completion date is 31 March 2021, with a 10-day final completion period.
