After posting the quote tab, an issue was raised concerning whether or not all vendors provided pricing for Ford Brand and Part Number as required by the RFQ. I contacted all vendors either by phone or by email to determine if Ford Brand and Part Number were quoted or whether some provided quotes based on an alternate. Based on the information, Gibson, Core & Main and Ferguson were providing Ford Products and Part Numbers as required by the RFQ. The others were providing an alternate. Since we did not specify that an alternative would be considered or accepted, we cannot award to those vendors. I also realized during this review that the quote tab was incorrect. Two vendors did not include taxes as part of their pricing. Therefore, I have calculated the taxes for them and revised those two quotes to include applicable state tax. The revised corrected quote tab is hereby provided. The low bidders for the three items are indicated in the quote tabulation.
