Response: Currently Georgetown County operates several stationary compactor units

that when the receiving container is removed from the power unit there are doors affixed to the receiving container that automatically shut, which keeps the materials in the receiving container. Operators are not required to add additional covers or close other doors to keep waste in. This ability is what is meant by "self-sealing".
