The City of Portales, NM, located In Roosevelt County, will plan, design, and construct wastewater system improvements in up to five locations as follows: 3rd & Kilgore Lift Station at latitude 34.185981 and longitude -103. 317847; Lime Street Lift Station at latitude 34.193568 and longitude -103.351604; NM 267 Lift Station at latitude 34.185827 and longitude -103.370481; Roswell Road Lift Station at latitude 34.167757 and longitude -103.364935; and, Roosevelt Road 7 Lift Station at latitude 34.156446 and longitude -103.361835.

In preparation for this project, Portales has already completed the following tasks: The five lift stations were inspected and an inspection report on each lift station's specific condition and rehabilitation needs was prepared. Portales had an emergency and needed to complete the mechanical rehabilitation of the Roosevelt Road 7 Lift Station. That rehabilitation included refurbishment of a flyght pump, purchase in installation of two new flyght pumps with mounting brackets, replaced two discharge connections and ball check valves, minicas 24 volt with 11 pin socket base relays were added to the electrical panel, and 40 foot of 6" C-900 piping (materials on hand). The emergency work performed on the Roosevelt Road 7 lift station did not include the coating of the wet well.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the "SU" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based.
