

RESOLUTION NO. 18-384

A RESOLUTION ACCEPTING THE LOW BID OF APM CONSTRUCTION, CORP., FOR THE CONSTRUCTION OF THE FIRST STEP SHELTER BUILDING IN THE AMOUNT NOT TO EXCEED \$4,336,300; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A PROJECT-SPECIFIC CONSTRUCTION CONTRACT WITH APM CONSTRUCTION CORP., CORRESPONDING TO THE BID AWARD; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for construction of the First Step Shelter building were duly called for and advertised; and

WHEREAS, all bids received were opened on September 7, 2018; and

WHEREAS, a bid from one local vendor was within 10% of the low bid submitted by APM Construction Corp.; and

WHEREAS, pursuant to § 30-86(b), City Code, the lowest bidder and the local vendor were invited to submit the best and final offers (BAFO) equal to or lower than the low bid by September 14, 2018; and

WHEREAS, APM Construction Corp. declined to submit a BAFO, and the only BAFO submitted was by the local vendor whose BAFO was higher than APM's bid; and

WHEREAS, the City Manager recommends acceptance of the bid submitted by APM Construction, Corp, as the lowest best bidder in the amount not to exceed \$4,336,300; and

WHEREAS, this amount is for base construction services, plus food service equipment; and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsive bidder is the following:


