**Addendum 01**

**Carport**

The purpose of this Addendum 01 to IFB 24-B0004 for Carport, dated July 24, 2023, is to list the key points of discussion from the mandatory site visit.

- Bonds **will** be required \*IF\* your total bid price is \$25,000 or greater. Bonds will **not** be required \*IF\* your total bid price is under \$25,000.
- The Contractor will be responsible to fabricate and install a 40-foot by 50-foot carport in the designated spot observed during the mandatory site visit. The carport will be installed on a level gravel surface and anchored in place. Contractor will be responsible for any and all equipment necessary for the installation.
- The City will be responsible for prepping the surface, removing the curb, and trimming back the tree.
- Additional questions are due no later than 12:00noon on Thursday, August 10, 2023. Questions may be submitted via e-mail to [asowers@cityofmyrtlebeach.com](mailto:asowers@cityofmyrtlebeach.com). Official time of receipt will be marked by the time the e-mail is received, and not by the time that it is sent. E-mail messages can take up to ten (10) minutes or more to be delivered to the intended recipient. All questions received by the deadline will be answered via addendum.
- The sign-in sheet from the mandatory site visit is attached and is hereby made a part of this addendum.
- Sealed bids are due in the Procurement Office no later than 2:00PM (local time) on Thursday, August 17, 2023. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.


