## Addendum 01 August 4, 2021 IFB 22-B0006 Recreation Park Fencing

The purpose of this Addendum 01 to IFB 22-B0006 for Recreation Park Fencing, dated July 26, 2021, is to list the key points of discussion from the mandatory pre-bid site visit.

- All fencing lengths are approximate. Bidder is required to do their own measurements.
- Two coats of black paint, with sufficient drying time between each coat, will be required on back stop posts, cross bars, and dugout posts at the Ned Donkle Complex.
- Any section of fencing that is removed at the Ned Donkle Complex must be replaced within the same week so that the fields can be used on Friday, Saturday, and Sunday.
- The Bidder will be responsible for the location of the phone pedestal. The City will be responsible for the location of the water line.
- At the Practice Field, contractor is to install a new 20-foot drive-through gate and a new 4-foot walk-through gate. At the Hammer Throw, contractor is to install a 20-foot drive-through gate constructed from two existing 10-foot roll gates and a new 6-foot walk-through gate. (Please note that these specifications are updated from the specifications initially published on the bottom of page 23 of the original bid document.)
- Bidders are encouraged to refer to the photographs provided at the pre-bid site visit. Anything labeled as "open" or "opening" means no gate.
- The City understands that there is an approximate 4-month lead time for some materials.
   The Notice to Proceed for the selected bidder will be issued in conjunction with those lead times.
- A bid bond must be submitted with your bid if your bid price is \$25,000 or greater. Only the selected bidder must provide payment and performance bonds.
- Additional questions are due no later than 12:00 noon (local time) on Wednesday, August 11, 2021. Questions may be submitted via e-mail to <a href="mailto:asowers@cityofmyrtlebeach.com">asowers@cityofmyrtlebeach.com</a> All questions received by the deadline will be answered via addendum.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Wednesday, August 18, 2021. No e-mail submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
