- Proper insurance and City of Myrtle Beach business license will be required before any work can begin.
- Cleaning of all court surfaces will be required.
- The specifications call for repairs only; no re-digging of any court surface is authorized.
- Courts will be resurfaced according to USTA standards.
- The time frame for work completion will begin on August 5, 2019 and must be completed by August 23, 2019.
- Proposals are due in the Purchasing Office no later than 2:00PM (local time) on Tuesday, July 30, 2019. The City of Myrtle Beach is not responsible for late or misdirected mail. No e-mail submissions will be accepted.






