- This is a 30 day project. Liquidated damages are \$500.00 per day. The Prime Contractor is responsible for 70% of the work.
- All markings on Ocean Boulevard shall include crosswalks on all four (4) sides.
- Some areas include removal and replacement of markings, however contract award will be based on unit prices of the bid price schedule.
- No night work will be allowed in the Market Common District except for parking areas.
