The requirements of this section do not apply to the notice provided in s. 200.065(3).

NOTE

Public comment: Prior to the adoption of s. 286.0114, F.S. (2013), Florida courts had determined that s. 286.011, F.S., provides a right to attend public meetings, but does not provide a right to be heard with the exception of "board or commission".
