This clarification is being provided to all known and registered correspondents in response to questions received. On Thursday, January 27, 2022, Georgetown County Purchasing and Facility Services staff in conjunction with Coastal Carolina University, held a public pre-bid conference and site inspection at the historic school house on Sandy Island. Attached is a copy of the agenda from that meeting as well as a copy of the sign-in sheet. Only those vendors with a representative present and showing on the attached sign-in sheet will be allowed to submit a bid. A vendor who submits a bid but is not represented on the attached sign-in sheet will be considered non-responsive.

There were no direct questions from bidders but below is a summary of items discussed along with clarifications for bidders:

Work must be completed within 30 days from the notice to proceed with final completion before the grant end period of April 30, 2022, as stated on pages 3-4 of the original bid document.

Certificate of Insurance (COI) will only be required from the awarded Contractor. As stated on page 4 of the original bid document, Brookgreen Gardens as well as Georgetown County will need to be named as an additional insured under the General Contractor's insurance.

There is now water onsite, a hose bib has been installed in the back of the building by Facility Services.

There is electricity on site.

At the pre-bid conference Facility Services had advised bidders that the Contractor would be responsible for furnishing their own boat and bathroom. However, in an effort to assist bidders, a key can be provided to use the school house bathroom facilities. CCU will work to secure everything prior to work starting. Additionally, below is a possible vendor for a barge if one is needed by the Contractor. This information is being provided solely to try to assist bidders. Bidders may choose to use the below vendor, choose to use an alternate vendor of their choosing, or may use their own boat/method of transportation that they may already have.
