**Question 1:** We are an owner run company and are therefore not required to have WC, but we can easily add that coverage. Is proof required to bid this project?

**Response:** A certificate of insurance will only be required from the awarded vendor at the time of contract signature. We do have a Statement of Independent Contractor's form that can be completed in waiver of Worker's Compensation insurance but it is only applicable if your firm employs three or fewer people and is only applicable to Worker's Compensation coverage. We would still require a certificate of insurance for General Liability from the awarded vendor.
