Question No. 1: I'm trying to view more information on this. Could you send the bid specs?

Question No. 2: What is the start date for construction?

Response: *The start date is June 27th, 2024.*

Question No. 3: What is the estimated value for this project?

Response: *There is no 'estimated value' or estimated cost for this project.*

Question No. 4: Are there union requirements for this project?

Response: *There are no union requirements for this project.*

Question No. 5: Can you please confirm if the pre bid meeting tomorrow on April 3rd is optional or mandatory?

Response: *Please be advised that the pre-submission meeting scheduled on Wednesday, April 3rd, 2024, at 10:00 a.m. is not mandatory.*

Question No. 6: Can the Proposer bid on two different solicitations, the Thalatta Estate Brick Paver Replacement and/or the Thalatta Estate Asphalt Parking Lot Refurbishing?

Response: *Yes, the Proposer may submit a proposal for each solicitation.*

Question No. 7: Can the equipment for the project be stored at Thalatta Estate?

Response: *Yes, the equipment may be stored at Thalatta Estate provided the successful Proposer agrees to assume full responsibility for any loss or damage.*

Question No. 8: Can the Proposer visit the site the project will be taking place?

Response: *Yes, the Proposer may visit the site during park hours which is listed at [Contact \(thalattaestate.com\)](http://thalattaestate.com).*

Question No. 9: What type of pavers should be used for the project?

Response: *Please reference the first bullet point on page 15 of the RFP.*

Question No. 10: Thalatta Estate is normally open to the public every day, but will it be closed during the construction schedule?

Response: *Yes, Thalatta Estate will be closed during the duration of the construction schedule.*

Question No. 11: What site will be used to store the bricks/pavers?

Response: *Please reference the fourth bullet point on page 15 of the RFP.*

Question No. 12: The RFP states to rework the existing subbase; does the contractor need to replace 6" to 8" of subbase?

Response: *Replace as needed to bring to proper level.*

Question No. 13: The RFP states adding 3/4" crushed rock as necessary to create minimum depth; can the Village provide the depth required of added crushed rock?

Response: *As stated, as needed to bring to 6-8" level.*

Question No. 14: Will the Village provide the pallets for the storage of the existing bricks?

Response: *The Proposer is to provide the pallets.*
