The City recently acquired a communications cable to attempt to connect to the fountain PLC using the old laptop and software that was previously used for this. This laptop hasn't been used for communications with the fountain for several years, but still contained the last version of software for programming the PLC. Test to establish communications were unsuccessful.

## A question was asked about the maintenance program aspect of the RFP.

The City is interested in reviewing any options the chosen vendor may have for an ongoing maintenance program, in whatever configurations might be available. Please include in the response any programs that you may have, or might be willing to provide, along with pricing and services provided.
