ADDENDUM NO. 1

Arlington County (hereinafter referred to as the "County") Invitation To Bid (ITB) No. 22-DES-ITB-LW-410 for the provision of County-wide Snow Removal Services is amended as follows:

- **ITB EXTENSION: SEALED BIDS WILL BE RECEIVED BY ARLINGTON COUNTY VIA VENDOR REGISTRY UNTIL 1:00P.M. ON THE 30TH DAY OF NOVEMBER 2021.** ALL CORRESPONDING REFERENCES TO THE BID OPENING DATE AND TIME SHALL REFLECT THIS CHANGE.
- **I. INFORMATION FOR BIDDERS, SECTION 23. METHOD OF AWARD IS HEREBY REPLACED WITH THE FOLLOWING:**

The County will award the contract to the lowest responsive, responsible Bidder. The lowest Bidder will be determined by the lowest Total Cost per line item on the County-Wide Snow Removal Services – Bid Sheet. Multiple awards may be considered for some line items depending on the County’s estimated need and number of units available for each line item. For multiple awards, the Contractor with the lowest Total cost per line item will be awarded first, and if for any reason they are not able to provide the requested number of units of that line item, the County will next request additional units from the next lowest responsive and responsible Bidder.

The County reserves the right to make a separate award of each line item, a section of items or all items, and to make an award either in whole or in part, whichever is deemed in the best interest of the County. Bidders may bid on one, some, or all items listed per section to be considered. Bidders should mark “No Bid” or “N/A” on the non-applicable section of the bid form(s). No response on any line item will be considered a “No Bid.”
