A Non-Mandatory Pre-Bid Conference was held on Tuesday, December 22, 2020 at 2:30 P.M. at County Conference Room B1-501, 1800 27th Street, Vero Beach, FL for the above-referenced project. The signin sheet is attached.

Meeting opened with Earl Masteller, of Masteller & Moler, Inc. the Design Engineer introducing everyone involved. The meeting was then opened for questions. The discussion is summarized below.

- 1. Pre-Bid Meeting: This was a non-mandatory pre-bid meeting. Two (2) bidding contractors attended.
- 2. <u>Bidder's Questions</u>: All questions are to be in writing directed to Indian River County Purchasing Department by e-mail purchasing@ircgov.com.
- 3. It is strongly recommended that everyone visit the site. There was a tour of the project area after the meeting.
- 4. Project grant funding is for the sewer portion of the project, not the water portion.
- 5. The project is residential in nature on both sides of the railroad track.
- 6. The project is on both sides of the railroad track but do not at any point enter the FECRR right-ofway.
- 7. Soils borings will be sent out as an addendum for information purposes only.
- 8. Engineer's Cost Estimate is \$4,400,000.00.
- 9. There are no Minority or Local Preference condition for this project.
- 10. Everything is in the right-of-way, no connections to residences are included with this contract.
- 11. There is not an FDOT permit for this project; however, there will be some sidewalk to be open-cut for the perpendicular connections. The FDOT does require the open-cut sidewalk to be either completed or shored up within seventy-two (72) hours of opening.
- 12. The contractor is required to pull the dewatering permit; all other permits have been, or will be obtained by Owner.
- 13. As stated in the Bid Documents, Bidder must be registered with and use, at their sole expense, the Department of Homeland Security's E-Verify system (www.e-verify.gov) to confirm the employment eligibility of all newly hired employees, as required by Section 448.095, F.S.. Owner, contractor, and subcontractors may not enter into a contract unless each party to the contract registers with and uses the E-Verify system. Contractor is responsible for obtaining proof of E-Verify registration for all
