 - b. Will the by-pass dampers be replaced? Michael Curkan replied, they won't be there anymore. The motorized dampers are there to modulate the airflow.
 - c. Removal of existing condensing units is part of the scope.
 - d. New condensing units are going on the ground.
 - e. All new copper to be installed, not using existing.
 - f. Is there demolition of the old pad? No, Suzanne Hunnicutt answered.
 - g. Who is responsible for the fire alarm? Nut sure, as we use different companies, asked the vendor to submit her question to Danielle Gilbert.
