- Q4 Will the County allow any exceptions to the terms and conditions of the bid?
A4 Without knowing the exact exception and requested change, the County must maintain as is.
- Q5 In cases where a distributor is answering an ITB, would the County be open to the Vendors providing manufacturer warranties instead of what is outlines in the PO Terms and Conditions #26 Warranty?
A5 The manufacturer warranties are acceptable.
- Q6 With the uncertainty with pricing ,would the County allow price increases in the event the manufacturer increases their price?
