IN THE MATTER OF AWARDING THE BID FOR GLOCK G45T TRAINING PISTOLS TO GT DISTRIBUTORS, INC. AND KIESLER POLICE SUPPLY INC.

WHEREAS, a Public Notice to Bidders requesting sealed bids for Glock G45T Training Pistols was published in the Washington Missourian May 31, 2023 edition for receipt by June 13, 2023; and

WHEREAS, two (2) bids were received from GT Distributors, Inc. and Kiesler Police Supply Inc.; and

WHEREAS, after due deliberation, consideration, and discussion with the Franklin County Sheriff's Office, it is the recommendation of the Franklin County Purchasing Department that the contract for Glock G45T Training Pistols be awarded to both GT Distributors, Inc. and Kiesler Police Supply Inc.; and

WHEREAS, the Franklin County Commission hereby finds and determines it is in the best interest of Franklin County to award the contract for Glock G45T Training Pistols to both GT Distributors, Inc. and Kiesler Police Supply Inc. for the cost not to exceed \$454.00 per Glock G45T Training Pistol.

IT IS THEREFORE ORDERED by the Franklin County Commission that the contract for Glock G45T Training Pistols be and is hereby awarded to both GT Distributors, Inc. and Kiesler Police Supply Inc. for the total cost not to exceed \$22,700.00.

IT IS FURTHER ORDERED that Sheriff Steve Pelton is authorized to execute any and all documents as may be necessary or desirable to carry out and comply with the intent of this Order, for and on behalf of the County of Franklin, Missouri.
