The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by underlining, deletions are indicated by ~~strikethrough~~.

1. The Bid Opening Date is hereby CHANGED from October 3, 2019 to October 7, 2019 at 2:00 PM.
2. ATTACHED please find a list of all vendors who received email notice of the ITB, or who logged onto the webpage, and what actions each took relative to this solicitation.
3. Answers to Bidders' Questions:

**Q1:** Plans indicate stabilized subgrade is to be constructed under the proposed curb, there is no pay item for stabilized subgrade – please provide stabilized subgrade pay item.

**A1:** Stabilized Subgrade associated with curb construction shall be included in the unit cost for curb construction for the various types of curb

**Q2:** The bid tab does not include any earthwork items such as excavation and embankment. Please provide pay items for the required earthwork.

**A2:** An additional LS bid item, "5 y", has been added to cover any earthwork on Project including excavation and embankment. A protected, revised excel spread sheet is posted online with the title, "ITB\_20013\_Add\_4\_BIS\_Revd"

**Q3:** MOT plans notes # 13 & 14 appear to contradict each other. Please provide clarification as to the intent of these notes and how these notes impact the ability to detour pedestrian traffic and keep pedestrian traffic outside the work phases.

**A3:** MOT note #13 indicates that all required detour signage and any temporary work to maintain an ADA path shall be in place at all times in accordance with MOT. At end of work day all required detour signage and temporary work must be in place if disrupted during daily work operations. MOT #14 is an indication that corner work at signalized intersection needs to be

restored as soon as possible including pedestrian signals to put back to normalized

**Q4:** The mot plans do not allow for the construction of cross walks and do not provide for clear zone hazard (drop offs) associated with construction adjacent to the travel ways. Drip off conditions associated with construction will require either low profile barrier wall along the work zone or the detour of traffic adjacent to the construction activities. In order to construct the brick paver crosswalks, vehicular detours will be required. Please provide concurrence that vehicular detours will be allowed.

**A4:** Limited time vehicular detours will be allowed for construction of crosswalks as concrete base is required to be installed and cured prior to vehicular traffic. These detours and time involved should be part of the submitted phasing plan to be submitted as show on sheet 3A of the plan set.
