The following changes and clarifications shall be made to the bid Documents for Landscape Maintenance Services

- Q1. Can optional services only be awarded to the contractor that is awarded the base fine mowing and maintenance?
- A1. It is the intent of the Village to award the bid and any selected optional services to a single Contractor.
- Q2. On the schedule of prices there are 28 cuts listed, however it states 30 cycles on page 21. Are there supposed to be 30 cuts?
- A2. Provide pricing for 28 cuts
- Q3. With regards to string trimming around curbs and curb lines, will the expectation be that all curbs are stringed trimmed on each visit?
- A3. Yes, trimming shall be completed during each mowing cycle.
- Q4. Since several of the detention areas have many weeds, thin turf, and no irrigation, what does it mean to spot spray invasive weeds? In turf areas described above one broadcast application will not eradicate weeds for the summer.
- A4. Turf areas are to be treated, buffer areas around ponds are not to be treated.
- Q5. Are the weed control and fertilizer applications only to be applied to finely mowed turf?
- A5. Yes

- Q6. Is there any colored mulch required at any of the tier 1 sites?

- Q7. Are any trees with turf up to the trunk expected to be edged and mulched?

## X. LITTER AND DEBRIS REMOVAL

The contractor shall be required to perform this activity on a year-round basis as detailed below.

Litter & Debris Removal Schedule:

Fire Stations 25, 26, and 27, Metra and Pace, Village Campus, Village Green and Well houses on Monday and Thursday each week.

All areas at each building/site are to be inspected and debris and litter shall be removed. This work is to include all medians, roadways, curb lines, parking areas, fence lines, sidewalks, planting beds, and turf areas.

All garbage and cigarette cans shall be emptied on a daily basis.

All litter collected shall be disposed of off-site by the contractor.

Contractor shall supply heavy duty leak-proof garbage bag liners.

Type of litter to collect (but not limited to) includes paper, metal, clothing, food, glass, wood, cigarette butts, and animal waste.

It shall be the responsibility of the contractor to keep all garbage and cigarette cans clean and odor-free.

Should a garbage can require cleaning, it shall be the responsibility of the contractor to do so per request of the Supervisor of Forestry and Grounds. Per direction of the Supervisor of Forestry and Grounds, the contractor shall set up a consistent daily schedule for each building/site.
