On February 28th, 2023, the City received insufficient bids in order to open. Therefore, this project is being readvertised. Sealed Bids for the construction of the indicated project will be received by the **City of Havelock** until the time and place stated herein, at which time the Bids received will be publicly opened and read aloud. All Bids submitted shall include one original set of the Bid Documents.

The Work is located at: **From existing SSMH G260 to SSMH G102
near E Main St, Havelock, NC 28532**

The Work consists of, but is not limited to, the following:

Furnishing all materials, labor, equipment, tools, etc. unless otherwise specified for the complete and operable installation of new sanitary sewer, manholes, and connections to existing sanitary sewer lines and services. The project also includes testing of new sewer, sanitary sewer

bypassing, traffic control, trenching, pavement repair, surface restoration, abandonment of existing sanitary sewer, and all associated appurtenances described or shown on the Contract Specifications and Drawings. The project specifically includes, but will not be limited to, the following:

- Installation of approximately 3,080 ft of 18-inch PVC sanitary sewer, including three jack and bore crossings.
- Removal of approximately 1880 LF and abandonment of approximately 1200 LF of existing sanitary sewer.
- Removal of approximately 13 manholes and abandonment of approximately 5 manholes on existing sanitary sewer.
- Installation of approximately 24 manholes.

The foregoing description shall not be construed as a complete description of all work required.

The Work will be financed by the American Rescue Plan Act (ARPA) grant funding. Bidder shall comply with Section 00 53 00 - Coronavirus State and Local Fiscal Recovery Funds Addendum.

Bids will be received for a **SINGLE** prime Contract. Bids shall be on a **UNIT PRICE BASIS** as indicated on the Bid Form. The Contract Times for the Work are set forth in the Agreement.

Each bid shall be submitted on the Bid Form furnished with the Contract Documents or on copies of the Bid Form furnished with the Contract Documents. Bidder shall submit Section 00 40 00 – Bid Form in its entirety unbound from the Contract Documents enclosed in a sealed envelope and addressed to **Lee Tillman, Director of Finance**, City of Havelock, 1 Governmental Avenue, Havelock, NC 28532. The name and address and the NC Contractor's License Number of the Bidder must be plainly written on the outside of the envelope, and the envelope marked "**Bid for Havelock HWY 70 Sewer Replacement Project.**"

No Bid shall be considered or accepted unless at the time of its filing the same shall be accompanied by a deposit with the City of Havelock of cash, or a cashier's check or a certified check drawn on a bank or trust company insured by the Federal Deposit Insurance Corporation, in an amount equal to not less than five percent (5%) of the Bid. In lieu of making the deposit as above provided, such Bidder may file a Bid Bond executed by a corporate surety licensed under the laws of North Carolina to execute such bonds; conditioned that the surety will upon demand forthwith make payment to the City of Havelock upon said Bond if the Bidder fails to execute the Contract in accordance with the Bid Bond. If upon acceptance of his Bid, a Bidder fails to enter into a Contract with the City of Havelock, the Bid deposit shall be forfeited to and become the property of the City of Havelock. No Bidder may withdraw his Bid within 60 days after the date of Bid opening.

A separate performance bond and payment bond each in an amount equal to one hundred percent (100%) of the Contract price will be required upon execution of the Agreement. Carriers must be authorized to do business in North Carolina.

Bidders must conform with the provisions of the North Carolina Contractor's Licensing Act of 1925, as amended.
