Question: Can you outline the titles/responsibilities of the five employees at each course?
Answer: There is a golf coordinator at each course. They manage all golf activities, they have only part-time employees. Each course has a superintendent, a full time mechanic and two full time crew workers and several part-time employees for course maintenance.

Question: Are there also part time employees at each course and if so, approximately how many in season?

Answer: Approximately 20 per course.

Question: Is the golf course maintenance done by the employees or through an outside contractor?

Answer: Employees

Question: Is there a PGA or LPGA Golf Professional working as a contractor at either course?
Answer: No

Question: Is there a driving range at each course?
Answer: 1 course has range.

Question: I could not locate any financial information on the website...can you share the most recent year's revenues and expenses by course?
