Offerors must demonstrate the ability/familiarity with the services identified and will be evaluated based on the criteria stated in the Proposal Requirements section. This is a single contract for services identified. Offerors may sub-contract for individual services.

Question 5: If the county will allow groups to bid on part of the scope of the RFP, will they allow groups to bid on part of the scope for a particular subset of the county geographically? Answer 5: Please see Answer 4. The services identified focus on low- and moderate-income residents who live throughout the County and may have concentrations in certain geographic areas.

Question 6: Will recipients be allowed to contract/sub-grant for services to a specific population or subset of the county geographically. Answer 6: Please see Answer 4 and Answer 5.
