The purpose of this Addendum #01 to IFB 23-0010 for Root Control dated October 25, 2022, is to list key points discussed in the mandatory pre-bid meeting:

- Bid and Payment/Performance Bonds for this contract are not necessary or required.
- Bidder must provide a Point of Contact for communications between the City and the bidder.
- The successful Contractor must notify the City of any issues that arise during the performance of work under this Contract.
- An electronic method of GPS tracking the Contractor's employees must be provided to the City by the Contractor during the performance of Contracted work.
- Any landscaping damage incurred either on public property or private property during the performance of work is the responsibility of the Contractor for repairs.
- The Contractor may only increase prices at the beginning of a Contract period and may have a maximum increase of five percent (5%) each year.
- Bids must be received by the Purchasing Office located at 3231 Mr. Joe White Avenue, Myrtle Beach, SC 29577 no later than 2:00p.m. (local time) on November 15, 2022. No late or electronic submissions will be accepted. The City is not responsible for late or misdirected mail.
