Grading (minor)  
Portland Cement Concrete (major)  
Flexible Paving (major)  
Hot Plant-Mix Bituminous Courses (major) and,  
Traffic Signal (minor)

**Question:** American Pipeline Construction: Requesting clarification on what documents are required to be submitted as part of Bid package.

**Response:** The submittal shall contain, but not limited to:

1. Bid Security of 5% based on bid price
2. Section (13 Forms) which starts on page 138 of the solicitation and ends on page 162.
3. Page 186 (Section 18)

4. Bid Sheets which start on page 189-190.
5. Certificate of Insurance or letter of insurability
6. List of Sub-Contractor (if using) page 156
7. Addendum acknowledgement sheet
8. Reference history at least (3) references with similar project scope
9. Appendix "C" on page 203 to 211 FDOT Required Forms
