Bohannon Huston, Inc. (BHI), in conjunction with County staff, prepared and solicited for bids for the Rehabilitation/Reconstruction of Taxiways and Aprons at the Grant County-Silver City Airport. On May 21, 2020, one (1) bid was received.

PROJECT INFORMATION

The scope of this project is for the reconstruction of three connector taxiways and a portion of the apron; the rehabilitation by seal coat of a portion of the taxiway system; and rehabilitation by mill and inlay a portion of the apron. The additive alternative is a mill and inlay of a portion of the taxiway as a substitute for the seal coat.

FUNDING INFORMATION

BHI has consulted with the Federal Aviation Administration (FAA) and the New Mexico Aviation Division (NMAD) on funding of this project. The County will submit an FAA Grant Application for the entirety of the base bid and the additive alternate 1. NMAD is also considering funding the amount not awarded by the FAA.

BID RECOMMENDATION

It is the recommendation of myself, BHI and the County Airport Manager that this bid be **Conditionally Awarded** to the sole bidder for a total amount listed above – subject to concurrence of and funding from the FAA and NMAD and receipt of the actual grants. All required documents were submitted with the bid. The required bid bond was submitted and there were no arithmetic errors in the bids. The bid appear to be reasonable for the work anticipated. The two addenda issued during the bidding process were acknowledged. The prime contractor and subcontractor's meeting the criteria for registration are registered with the Labor Enforcement Fund.

The certification for Contract Documents, Specifications and Drawings in electronic form was provided.

The Disadvantaged Business Enterprise (DBE) goals is 10.7%

The bid contained a Base Bid with one Additive Alternative.

The Plan Holder's List and the contractor evaluation is attached.

The qualified low bidder, Southwest Concrete and Paving, Inc. holds a correct and current New Mexico Contractors license as verified via the State CID web site. Registration with the Labor Enforcement Fund for the prime contractor was verified. The contractor is not on the Federal suspended or disbarred contractor listing, nor is on the State list of suspended or debarred contractors. The Bid Bond was issued by a company listed in Federal Register Circular 570.

All other bidding requirements appear to be in compliance with the bidding documents.

BHI has consulted with the FAA and NMAD on funding available for this project. Based on these consultations, we have been requested to submit an FAA grant application for the entirety of the base bid and additive alternate 1.

NMAD is also considering funding the amount not funded by the FAA.

Based on this we recommend Grant County accept the bid for Grant County-Silver City Airport Improvements-2020 Rehabilitate/Reconstruct Taxiways and Aprons from Southwest Concrete, Inc. subject to the concurrence of and funding from the Federal Aviation Administration and the NMDOT - Aviation Division, and receipt of the actual grants; award a contract for the Base Bid and Additive Alternate 1 in the amount of **\$ 2,154,770.00** excluding NMGRT.

NMGRT at the current County rate of 6.5625% should be included in the project budget for an overall construction budget amount of **\$ 2,296,176.78**.
