SUBMIT OFFER BY (OPENING DATE) AND TIME HAS CHANGED: The New submit offer by (Opening Date) is now **June 25, 2020** at 1:30PM.

POTENTIAL BIDDER QUESTIONS: Answers are provided below questions

1. Where is the closest fire hydrant that can be connected to and metered for the temporary irrigation water supply?

Answer: The hydrant in front of the schools should be the closest, the one scheduled to be re-located. This hydrant should be active except for the short period of time the contractor is re-locating it.

2. Who owns the hydrant? HCS or GSWSA?

Answer: It is our understanding the hydrant is owned by GSWSA. The backflow vault for the school is downstream of this hydrant is addressed in Addendum one (1).

3. Who will be responsible for maintain/cutting the sod for the first year?

Answer: The contractor.

4. Will the rest of the fence around the new loop be 4' tall galvanized to match existing pond fence?

Answer: 6' around pond and anywhere else the existing fence is 6', 4' elsewhere.

5. Is any of the cut from the road/etc. usable on-site or should it all be hauled off?

Answer: Per Geotech report we do not anticipate the near surface soils to be re-usable on site. Most near surface soils are fat clays. If pockets of good material may be encountered, they should be evaluated for re-use by the project geotechnical engineer on a case by case basis.
