Each vendor may submit more than one bid provided each bid meets the stated specifications. Each bid must be submitted in a separate sealed envelope with the appropriate notation on the outside. All bids must be signed by an authorized agent and submitted on the prescribed forms. Submission of bids by telegraph, telephone, or other electronic means is strictly prohibited. Any brand name called for the bid specifications is provided as a reference only. Alternate brand name items offered for bid must be equivalent as to function, basic design, type and quality of material, method of construction, and any required dimensions. Bidder must attach a letter of exception to specifications.

This addendum becomes a part of the Contract Documents and modifies the original specifications as noted.

### **Changes to the Contract Documents & Specifications:**

#### Item #1

Issue: 2.1.3 Emin requirement vs.10,000 divisions limit.

<u>Response:</u> A 10 lbs increment is doable the scale capacity up to 100,000. If the bidder submits a scale with capacity above that which is required in the plans, it is acceptable to have an increased readout increment to prevent noncompliance with NTEP requirements for maximum divisions.

Revised Bid Proposal: None other than this addendum.

#### Item #2

Issue: 2.1.4 deck design clarification.

<u>Response:</u> Orthotropic concrete deck design will be acceptable in addition to current requirement. Also, the thicknesses of the deck and the deflection allowed in the deck may be modified to manufacture specifications so long as the CLC requirements and NTEP specifications are maintained as stated in the bid documents. Last, the requirement for side access installation and service of load cells is revised to allow top (deck plate) access with no other modifications to deck loading requirements.

<u>Revised Bid Proposal:</u> None other than this addendum.

#### Item #3

Issue: 1.0.6 load cell optically isolated

<u>Response:</u> Depending on the load cell construction, surge voltage protection may vary by manufacturer. This section of requirements concerning the optical isolation shall be revised to allow varied surge voltage protection so long as the modification is to the scale manufacturer's recommendation and fully compliant with the required manufacturer's warranties.

Revised Bid Proposal: None other than this addendum.

#### Item #4

Issue: 2.1.5 Load cell checking clarification

<u>Response:</u> We understand that each manufacturer has a specific design to their load cells and consequently provides varied approaches to checking design. This section shall be revised to allow each manufacturer to offer their specific checking design. The checking method proposed shall be one that allows individual load cell checking (not composite system only) and provide information in enough specificity to identify potential load cell issues prior to complete failure.

Revised Bid Proposal: None other than this addendum.

#### <u>Item #5</u>

Issue: 2.1.6 Load cell design specifications and warranty

Response: The style of load cell design as rocker column is waived. No revisions occur to the minimum capacity or NTEP accuracy class. The dust/water hermetic seal shall not be less than IP66. Each bidder shall supply the subsequent specification information for other categories as supplied by the scales manufacturer. The minimum warranty for the load cell is revised to 5 years. Each bidder shall also include an add alternate for supplying a scale system including a 25+ year warranty on the load cells.

Revised Bid Proposal: Bid Form, Page B-3 (see attached)

#### Item #6

Issue: 1.0.4 Paint coating is very specific and most manufactures have quality paint

<u>Response:</u> Section shall be revised to comply with the scale manufacturer's recommended paint/coating scheme. The requirement for field painting other than touch up to damaged surfaces shall remain.

Revised Bid Proposal: None other than this addendum.
