This addendum is hereby incorporated into the Bid Documents for the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by underlining, deletions are indicated by ~~strikethrough~~.

1. Page 27, "Non-collusion Affidavit of the Prime Bidder", and pages 28-29, "Affidavit on Public Entity Crimes", and page 30, "Local Vendor Affidavit" are hereby REPLACED with modified "Non-collusion Affidavit of the Prime Bidder" and "Affidavit on Public Entity Crimes" and "Local Vendor Affidavit" eliminating the notary public requirement during the COVID-19 crisis to comply with online bidding requirements. Failure to include these and other required forms will render the Bid non-responsive and in eligible from consideration for award.
2. Questions and Answers:
 - Q1: Did the city not replace these batteries in 2018?
A1: **Bid 0218-1870 that you are referring to was to replace batteries at the Bethune Point Plant. This bid is to replace them at Westside Regional. They are two different locations.**
 - Q2: Is there a loading dock at site?
A2: **There is no loading dock at this site.**
 - Q3: How far is the UPS from the entry point?
A3: **N/A, Please see above answer.**
 - Q4: Is the UPS on the first floor?
A4: **Yes, there is about a 18' rise between the roadway and the door (See Figure 1)**
 - Q5: If not, is there an elevator we can use?
A5: **No**
 - Q6: Can the batteries be stored at the loading dock 1-2 days before install?
A6: **No**

Q7: Is there a pallet jack on site we can use?

A7: No

Q8: Any floor protection needed?

A8: It is a concrete floor, any damage to the floor during the project will need to be repaired.

Q9: Are there any obstructions from the loading dock to the UPS?

A9: N/A

Q10: Is the job to be completed during normal or off hours?

A10: Normal Hours 0700 to 1600, System must be operational at the end of each business day.

3. All other terms and conditions remain the same.
