Add new paragraph:

5.1.5 SURVEYING:

Surveying of the proposed building site and the site of incoming water main and other related areas items required to provide complete information for the design of the proposed "Booster station is part of this contract. This contract shall engage and pay for all needed surveying services to complete the design of this project. A copy of the completed survey shall be made available to owner, one (1) electronic copy and one (1) paper copy. In additions to site surveys, the project manager/ project engineer shall visit the site prior to start of design and make themselves familiar with the sites and there surrounding conditions..

QUESTIONS:
