GENERAL

QUESTIONS

- 1Q. Is there a Geotechnical report available for each site?
- 1R. No.
- 2Q. Can alternative turf manufacturers be submitted for substituted?
- 2R. The documents do not have a specific turf manufacturer listed. The specifications do include specific criteria to be followed. Turf submittals made with the Bid/Proposal must meet the minimum specifications.
- 3Q. Can alternative turf systems be submitted for substitution?
- 3R. An alternative turf system may not be submitted for consideration in the Base Bid/Proposal. An alternative system can be submitted as either an Additive or Deductive Alternate listed in Optional Value Add/Delete Alternates portion of the Bid/Proposal Form with the corresponding dollar value to be considered.
- 4Q. Can Rakortan WBS BS Synthetic Track Surfacing be considered an Owner approved equal to the specified Basis of Design in Section 32 18 23.33 Running Track Surfacing for use at Ooltewah High School?
- 4R. Yes.

SPECIFICATIONS

ITEM 1 Section 32 18 14 – Infilled Synthetic Turf Systems

Replace Paragraph – 1.12D

Replace with: "Subsurface turf base and drain trench shall include, from the top: 2" of #89 stone and a depth of #57 stone to complete the cross-section. Cross-section varies by location due to storm drainage requirements. Install clean #57 stone surrounding the subsurface collector drainage pipe."

ITEM 1 HHS, OHS, SDHS – Sheet C7.01, Detail 1 – Replace "1/4" MINUS" with

"#89". Revised drawing will not be issued as part of this Addendum.

ITEM 2 OHS – Sheet C7.02, Detail 7D – Add 1 ½" Asphalt Top Surface and 1 ½"

Binder Course with 6" depth Compacted Aggregate Base for the field events added to OHS and for repairs to be made to the existing track.

Revised drawing will not be issued as part of this Addendum.
