Question #1: Asked during site visit: What is the current system?

Answer #1: Pelco.

Question #2: Asked during site visit: Did you say it's a one for one on the cameras?

Answer #2: Yes, with the exception of the busway and a few others.

Question #3: Asked during site visit: What about cabling?

Answer #3: Everything will need to be replaced.

Question #4: Asked during site visit: Cat6?:

Answer #4: Yes.

Question #5: Asked during site visit: Are you wanting to go back to the original Avigilon server?

Answer #5: No, a new Avigilon server should be included in your proposal.

Question #6: Asked during site visit: Is there a commitment on installation? Like after the intent to award?

Answer #6: Just looking to have someone start as soon as possible as long as it fits with KAT's schedule.

Question #7: Asked during site visit: Are there hours that will change?

Answer #7: Normal business hours as stated.

Question #8: Asked during site visit: Does the 15 days include the superstops and cabling?

Answer #8: Yes

Question #9: Asked during site visit: Do you want patch panels and patch cables?

Answer #9: Yes, it needs to be turnkey.

Question #10: Asked during site visit: Is all cabling in one location?

Answer #10: No. There is an equipment room on the busway and a Telecom space in the Security Office.

Question #11: Asked during site visit: Does it have to be Panduit?

Answer #11: You can bid what you'd like, but PBA has an internal standard of Panduit.

Question #12: Asked during site visit: Who will be doing the monitoring?

Answer #12: PBA and a few KAT employees have access.

Question #13: Asked during site visit: Would you prefer crimp?

Answer #13: No, a surface mount box with modular jack so permanent link tests can be performed.

Question #14: Asked during site visit: All coax demo'd?

Answer #14: Yes.

Question #15: Asked during site visit: Is the pathway good?

Answer #15: Yes.

Question #16: Asked during site visit: On outdoor cables, do you want lightning protection?

Answer #16: We don't now, but have added "outdoor rated" to the specifications. See Addition #1.

Question #17: Asked during site visit: So anywhere there is a camera, there will be access?

Answer #17: Yes.

Question #18: Asked during site visit: Do you need ethernet extenders?

Answer #18: Yes.

Question #19: Asked during site visit: How high are the superstop cameras?

Answer #19: You will need access to a bucket truck or lift.

Question #20: Asked during site visit: The other side of the shelter has a blind spot, do you need additional cameras there?

Answer #20: No, the cameras can be lowered to eliminate any blind spots.

Question #21: Asked during site visit: For bonds, we just need to quote the price, right?

<u>Answer #21:</u> For the Performance and Payment bonds, yes, but you are required to provide a bid bond with your submittal.

Question #22: Asked during site visit: Is this electronic or paper submittal?

Answer #22: Paper, two copies with one original.

Question #23: Asked during site visit: Is the 15 days a hard deadline?

<u>Answer #23:</u> That is the desired timeline. If your firm has a different timeline in mind, that needs to be part of your proposal and must be met, no exceptions.
