This addendum will amend **BID #23-002, Murrells Inlet Bike Path Parking Facility** originally issued on Friday, February 3, 2023. This clarification is being provided to all known and registered correspondents in response to questions received. Question 1: For the Pervious Concrete it is listed as square yards but I believe this must be square footage. It has 2400 SY on the tabs when it is closer to 2400-2600 SF by the plans. Could you please confirm how you would like us to bid this, either in SY or SF? This is a big item and want to make sure we do it the same as everyone else.

Response: **Change to SF to match the plans. The SY noted on the bid tab is an error. Also, the County is reviewing some potential utility conflicts. Therefore, the County will push the bid opening back two weeks. See revised bid opening date and time below. A 3rd addendum will be issued once staff and engineers have had a chance to review/revise proposed conflicts.**
