The purpose of this meeting is for the Broward County Housing Authority (BCHA) to interview the respondent to the above RFP and recommend whether or not to enter into an agreement, should the evaluation committee **determine that an interview is warranted at its scheduled public meeting on June 27, 2023**. The prospective meeting will be divided into two portions. One portion will be open to the public, and the other portion will be a shade session during which the Evaluation Committee will conduct an interview of the respondent.

The shade session portion of the public meeting will not be open to the public pursuant to Section 286.0113(2)(b)1, Florida Statutes. The shade session portion of the meeting will be attended by, Teisha Palmer, Procurement Manager; the BCHA Evaluation Committee members; and the respondent. It is anticipated that the shade session portion of the public meeting will be held from 1:15 p.m. – 2:00 p.m. on June 28, 2023.

In accordance with Section 286.011, 189.015, and 189.069 Florida Statutes, the portion of the evaluation committee meeting that will be open to the public will be on **June 28, 2023** from *1:00 p.m. - 1:15 p.m., and then following the interview shade session scheduled to end around 2:00 p.m*.

Please be aware the Evaluation Committee meeting is a public meeting, and not a public hearing. Therefore, the Evaluation Committee will not receive public comment during the public meeting.
