Effective this date, this amendment forms part of the contract documents and modifies the original IFB

The following questions have been submitted for responses and/or clarification:

Question #1: "Please provide dimensions/size of the sanitary septic tank to be removed and disposed at Buford High School Baseball Field?"

Answer #1: The septic tank at Buford High School Baseball Field is a 6" well (1,000 gallon) tank. (C300)

Question #2: "C500- Mentions 2" double check valve assembly to be installed at Buford High School Baseball Field by Owner's contractor. Please confirm this scope is to be included in the pricing for this solicitation."

Answer #2: Yes, the contractor is responsible for the assembly of the 2" double check valve and pricing for this assembly needs to be in the contractor's bid price.

Question #3: "Please provide size and depth of well to be abandoned at Lancaster High School Baseball Field?"

Answer #3: The well is a 6" well but the depth is unknown. (C300)
