Mr. Steven Gonzalez from OrchidMan Landscape Artisans, Corp. submitted the following questions via email:

1. **Question:** I wanted to know if you can send a copy of the addendum that was posted two days ago according to the Village website.

Response: Please note that the website only shows the .pdf of the actual bid and what was later posted is a map of Palmetto Bay. This is the first and only addendum.

2. **Question:** I would like to know if there is a list of current properties on this program and what is the average size of the lots.

Response: Yes, there is a list:

And, the size of the properties can vary from 7500 square feet to well over 5 acres. The typical property and vast majority are anywhere from 12,000-18,000 square feet.

3. **Question:** In regards to the above RFP, under the schedule of events there appears to be no prebid meeting. Please advise if there is going to be one, if it is mandatory or not, and if there is no pre-bid meeting why not? Having a mandatory pre-bid meeting would limit the competition field to those local companies.

Response: You are correct, there is no pre-bid meeting, and we schedule pre-bid meetings when we have a complex scope. This bid is not considered complex, there is a table of services on the RFP that require you to fill in the prices. As the procurement specialist, we do not put limits on the competition; it defeats the purpose of good bidding. We will however, after shortlisting the bids will be calling the short list vendors and talk about the bid and respond to any questions they may have or concerns.

- 4. **Question:** Under section 5.3 Preparation of Proposals the following documents are not listed as to which section they would belong to:
 - 1. Sub-Contractor List
 - 2. Public Entity Crimes Sworn Statement
 - 3. Acknowledgement Warranty and Acceptance
 - 4. ADA Statement
 - 5. Business Ownership Affidavit
 - 6. Acknowledgement of Conformance w/ OSHA Standards
 - 7. Anti-KickBack Affidavit
 - 8. Statement of Past Contract Disqualifications
 - 9. W9

Response: Under Section 3.10 there is the same list stating that you will find these forms in Section 6. To add to that, there is also Drug-Free Workplace Certification, Non-Collusive Affidavit and Reference Form which is also included in Section 6 that was not on the list. I have made the correction added these as well.

5. **Question:** Please advise if you would like a section 11 to be added to the proposal, or will these documents be needed for the signature of the contract if the bid is awarded. Also, under section 9, there is no document listed as Independent Affidavit in the attachments. Please advise if there is a mislabeled document within the attachments or if one will be sent out.

Response: All the forms that have been provided are the ones that need to be turned in. Please note that section 9 is for exhibits. The Independent affidavit is the business affidavit that can be used for both. I will make a correction to the document to avoid confusion moving forward.
