- THE COUNTY HAS RECEIVED THE FOLLOWING QUESTIONS IN RESPONSE TO THIS ITB. QUESTIONS AND RESPONSES ARE INCLUDED BELOW.
 - O Question 1: Is a Bid or Performance Bond required with this contract?
 - Answer 1: No
 - Question 2: Section 9 Page 13- has a Recyclable Material Sort been done in 2022? If so, please provide the commodity percentage breakdown.
 - Answer 2: No sort was done in 2022.
 - Question 3: How will the recyclable materials be delivered to the MRF?
 - o Answer 3: A third party Contractor hired by the County will do the hauling.

- Question 4: How is the location/mileage determined, I don't see mileage differential.
- Answer 4: Mileage is not included because there's no hauling responsibilities in this contract.
- Question 5: What type of trucks deliver for curbside?
- Answer 5: Rear loading trucks
- Ouestion 6: What does the schedule look like?
- Answer 6: Collection takes place Monday-Friday and occasionally on Saturday for residential customers. Approximately 4-6 trucks will deliver residential materials on collection days. Collection occurs on all holidays except Thanksgiving, Christmas, and New Year's Day. For APS and county facilities the schedule varies, but bidders can anticipate at least one truckload per weekday.
- Question 7: Can request from other entities to ride the awarded contact be approved by such vendor?
- Answer 7: Yes, per paragraph 28, the bidder has the option of extending the contract to other entities.
- Question 8: Will the county consider 3 mix glass for the commodity instead of Flint glass?
- o Answer 8: No, the county will use Flint glass.

- Question 9: Does the county mean Mixed Paper Index to be Mixed Paper (54), rather than Mixed Paper (26)?
- o Answer 9: Yes, in Section #9 of the Scope it should read as follows:
 - *Mixed Paper*: Any paper fiber material that is not old, corrugated containers shall be considered mixed paper for calculation of payment. The unit price paid for each ton of mixed paper shall be determined as a percentage of the, RISI Pulp & Paper News or Transacted Paper Stock (low grades), #26-#54 Northern and Southern Mixed BHK, US East as published in RISI on the 5th of each month in which the material is delivered to the Contractor. If the RISI lists a range of prices, the highest price of the range shall be used. Each month the price of the commodity may vary based on the published price in RISI.
- Question 10: Will the county consider using the first index price of the month from Recycling Market instead of the 15th?
 Answer 10: No, the county will use the pricing posted on the 15th of the month as specified in the bid.

The balance of the solicitation remains unchanged.
