Reasoning for Addendum #2:

We are issuing this Addendum #2 to clarify the Specifications sent out with Addendum #1.

All stipulations from the original solicitation and Addendum #1 apply.

You must acknowledge Addenda #1 and #2 on page 2 of the original bid form.

Clarifications/changes are highlighted below in yellow:

SPECIFICATIONS:

NEW – ALTERNATE BID – Nation Ford High School – Student Drop-off Line

- Mill, apply liquid tack coat, and repave alligator/pot hole areas in student drop-off line
 - 2 inches (and we are assuming a good 2 inch base exists.)
 - To clarify, contractor must mill any alligatoring areas and repair potholes along student drop-off line. There is a large area of alligatoring right along the sidewalk close to the school that we specifically pointed out, but there are also potholes that must be repaired close to the student drop-off line entrance. The whole student drop-off will then need to have topcoat and seal applied.

Sugar Creek Elementary School - Front Driveways and Parking

Mill and Repave parking areas and drive ways between school building and Stop Sign at beginning of school driveway. Mill and Repave the middle drive in the parking lot and all parking spaces. Hot crack seal & top coat for the drive from the stop sign in to the school. Only the parking spaces and middle drive in the parking lot will be milled. Contractor will hot crack seal and top coat the drive into the school from the break just before the stop sign in to the school. The break will be right where there is some existing fairly new pavement that was previously repaired.

- <u>Mill up</u> all existing asphalt/pavement in student parking areas.
 2 inches
- <u>**Reset sub-grade**</u> for water flow and compact as required.
- <u>Clean and remove</u> any residual debris within same areas.
- <u>Apply liquid tack coat</u> to all applicable areas.
- <u>**Pave**</u> all areas with surface course asphalt over tack coat.
- <u>**Compact**</u> all areas with heavy duty vibratory asphalt rollers.
- <u>Stripe</u> all driveways with appropriate markings and all parking areas for maximum parking spaces allowed. Please stripe center line to create lanes for drive into school.
