BACKGROUND/ANALYSIS:

District staff seek Board approval of an Agreement for Construction Services ("Agreement") with Angotti & Reilly, Inc. ("Angotti") in the amount of \$183,000.00 for the Removal and Replacement of Existing Front Lobby Entrance Doors Project ("Project") at Berkeley City College.

On August 17, 2022, District staff issued an Informal iBid 22-23/01 pursuant to CUPCCAA for the Project. Angotti's bid form was the only response received by the August 30, 2022 deadline.

Based on the foregoing, the District recommends the Agreement for the Project be awarded to Angotti. Per the Agreement, Angotti will provide the general contracting and related services needed throughout the life of the Project pursuant to the terms and conditions of the Agreement, which includes the submitted bid. All work performed shall comply with the Division of State Architect ("DSA") approved construction documents and applicable codes and regulations.
